ORGANIZATIONAL MANUAL UPDATES

WHEREAS, *The General Council of the Assemblies of God Organizational Manual* was recently revised to align with current day practice; subject to General Presbytery approval; and

WHEREAS, The 2023 Constitution and Bylaws are not in alignment with the changes proposed in the newly revised Organizational Manual; therefore be it

RESOLVED, That General Council Bylaws, Article III. DUTIES OF OFFICERS, PRESBYTERS, EXECUTIVE LEADERSHIP TEAM, Section 1. Duties of the General Superintendent, paragraph n, page 30, which reads:

n. Lead Tier I leadership, executive officers, and the Executive Presbytery.

Be amended to read:

n. Lead Tier I corporate senior leadership, executive officers, and the Executive Presbytery.

And, be it further

RESOLVED, That General Council Bylaws, Article XII. *THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD ORGANIZATIONAL MANUAL*, pages 74–75, which reads:

The General Council of the Assemblies of God shall develop and maintain a set of documents referred to as *The General Council of the Assemblies of God Organizational Manual*. This document shall set forth in detail the organization of commissions, divisions, departments, and ministries of The General Council of the Assemblies of God as from time to time may be established to carry out the fourfold mission of the church.

The General Council of the Assemblies of God Organizational Manual shall be administered by the Executive Leadership Team as approved by the Executive Presbytery. The Executive Presbytery shall submit annually to the General Presbytery for approval all proposed additions, deletions, and modifications to *The General Council of the Assemblies of God Organizational Manual*. *The General Council of the Assemblies of God Organizational Manual* shall be available to all General Council affiliated churches and ordained or licensed ministers.

13 alignment with a revision made to The General Council of the Assemblies
14 of God Constitution and Bylaws. The Executive Presbytery shall submit
15 annually to the General Presbytery for approval all proposed additions,
16 deletions, and modifications to *The General Council of the Assemblies of*
17 *God Organizational Manual*. *The General Council of the Assemblies of God*
18 *Organizational Manual* shall be available to all General Council affiliated
19 churches and ordained or licensed ministers.
