#### **WEDNESDAY, AUGUST 2, 2023**

On August 2, 2023, at 1:30 p.m., General Superintendent Douglas E. Clay opened the 60th General Council of the Assemblies of God. General Secretary Donna L. Barrett was present.

#### INTRODUCTION OF LEGAL COUNSEL AND PARLIAMENTARIAN

By general consent, a motion was adopted to allow Kristen Waggoner, Assemblies of God general counsel, and Sarah E. Merkle, parliamentarian, to address the body as may be called for by the chair or at the request of the body.

Jerehmy Owen moved that the voting for the AGWM executive director be suspended until the completion of an externally led investigation into AGWM organizational leadership at every level, and into AGWM policies, practices, and finances, and that the investigation be completed with transparency to the General Council. The chair ruled the motion out of order because the General Council's governing documents require the AGWM election to be conducted at the General Council session. The general secretary noted that an investigation could be requested after the General Council session through the proper process.

# RESOLUTION 2—ORDINATION REQUIREMENT FOR GENERAL PRESBYTERS

On behalf of the General Presbytery, Nathan L. Sheridan a member of the Resolutions Committee, moved adoption of the motion that follows. The motion was adopted as presented.

- WHEREAS, There is mounting value in our Fellowship being placed on the role of ordination; and
- WHEREAS, Most presbytery roles at the district level require the minister to be ordained; and
- WHEREAS, It has become the growing practice and expectation over time that all general presbyters are ordained ministers; and
- WHEREAS, It would seem contrary to our culture and values to bypass an ordained minister to place a nonordained candidate on the General Presbytery; therefore, be it
- RESOLVED, That all general presbyters shall be ministers ordained with the Assemblies of God; and, be it further
- RESOLVED, That General Council Constitution ARTICLE IX. OFFICERS AND PRESBYTERIES OF THE GENERAL COUNCIL, Section 3. General Presbytery, paragraph a. Representation, qualifications, and responsibilities, page 17, which reads:

#### **Section 3. General Presbytery**

a. Representation, qualifications, and responsibilities. The General Presbytery shall be composed of individuals of maturity, experience, and ability whose lives and ministry are above reproach, who shall represent the Fellowship in all phases of its work in their respective fields. The General Presbytery shall be the

official policy-making body of the Assemblies of God when the General Council is not in session. Each district shall have the privilege of representation on the General Presbytery by three members—the district superintendent together with two others who shall be elected by their district council, one of whom shall be an ordained pastor of a church located in the district. They shall take office immediately.

#### Be amended to read:

#### **Section 3. General Presbytery**

Representation, qualifications. and responsibilities. The General Presbytery shall be composed of ordained ministers individuals of maturity, experience, and ability whose lives and ministry are above reproach, who shall represent the Fellowship in all phases of its work in their respective fields. The General Presbytery shall be the official policy-making body of the Assemblies of God when the General Council is not in session. Each district shall have the privilege of representation on the General Presbytery by three members—the district superintendent together with two others ordained ministers who shall be elected by their district council, one of whom shall be an ordained pastor of a church located in the district. They shall take office immediately.

RESOLVED, That General Council Constitution ARTICLE IX. OFFICERS AND PRESBYTERIES OF THE GENERAL COUNCIL, Section 3. General Presbytery, paragraph c. World and U.S.

Missions representation, page 18, which reads:

c. World and U.S. Missions representation. The foreign fields shall be represented on the General Presbytery by the regional directors and the International Ministries director of Assemblies of God World Missions and by two others from each of the overall areas which the regional directors and the International Ministries director represent. [See Bylaws, Article II, Section 2, paragraph d, (2)] The stateside missions work shall be represented on the General Presbytery by the departmental directors of Assemblies of God U.S. Missions. [See Bylaws, Article II, Section 2, paragraph d, (3)]

Be amended to read:

c. World and U.S. Missions representation. The foreign fields shall be represented on the General Presbytery by the regional directors and the International Ministries director of Assemblies of God World Missions and by two others <u>ordained missionaries</u> from each of the overall areas which the regional directors and the International Ministries director represent. [See Bylaws, Article II, Section 2, paragraph d, (2)] The stateside missions work shall be represented on the General Presbytery by the <u>ordained</u> departmental directors of Assemblies of God U.S. Missions. [See Bylaws, Article II, Section 2, paragraph d, (3)]

And, be it further

RESOLVED, That General Council Bylaws ARTICLE II. ELECTION OF OFFICERS AND PRESBYTERS, Section 2. Nominations and Elections, paragraph d. General presbyters, subparagraph (2), page 27, which reads:

Assemblies of God World Missions representatives. Regional directors and the International Ministries director of Assemblies of God World Missions, representing the missionaries from their respective areas, are members of the General Presbytery by virtue of office. Two additional representatives on the General Presbytery from each region and International Ministries shall be chosen in the following manner: The Assemblies of God World Missions Board shall nominate four missionaries from each general area and International Ministries represented by the regional directors and the International Ministries director. Nominees will be selected from missionaries who will be in the United States at the time of the General Presbytery meeting and who preferably have had administrative experience in the field. Ballots shall be sent to all missionaries in each area who shall by vote select two to represent them on the General Presbytery. These shall be mailed to the general secretary who shall prepare a report to the Executive Presbytery. A simple majority vote shall be required to elect.

#### Be amended to read:

(2) Assemblies of God World Missions representatives. Regional directors and the International Ministries director of Assemblies of God World Missions, representing the missionaries from their respective areas, are members of the General Presbytery by virtue of office. Two additional representatives on the General Presbytery from each region and International Ministries shall be chosen in the following

manner: The Assemblies of God World Missions Board shall nominate four <u>ordained</u> missionaries from each general area and International Ministries represented by the regional directors and the International Ministries director. Nominees will be selected from missionaries who will be in the United States at the time of the General Presbytery meeting and who preferably have had administrative experience in the field. Ballots shall be sent to all missionaries in each area who shall by vote select two to represent them on the General Presbytery. These shall be mailed to the general secretary who shall prepare a report to the Executive Presbytery. A simple majority vote shall be required to elect.

#### And, be it further

RESOLVED, That General Council Bylaws ARTICLE II. ELECTION OF OFFICERS AND PRESBYTERS, Section 2. Nominations and Elections, paragraph d. General presbyters, subparagraph (3), page 27, which reads:

(3) Assemblies of God U.S. Missions representatives. Departmental directors of Assemblies of God U.S. Missions shall be members of the General Presbytery by virtue of their office.

#### Be amended to read:

(3) Assemblies of God U.S. Missions representatives. Ordained departmental directors of Assemblies of God U.S. Missions shall be members of the General Presbytery by virtue of their office.

#### And, be it further

RESOLVED, That General Council Bylaws ARTICLE II. ELECTION OF OFFICERS AND PRESBYTERS, Section 3. Vacancies, paragraph c. General presbyters, subparagraph (1), page 30, which reads:

#### c. General presbyters

(1) In the event a general presbyter shall move to another district or shall vacate the office for any other reason, the presbytery of the district council shall appoint one to serve as general presbyter until that office is regularly filled at the next meeting of the district council.

International Ministries shall be represented on the General Presbytery by its director and two others. [See Bylaws, Article II, Section 2, paragraph d, (2).]

j. General Presbytery representatives. Each of the regions shall be represented on the General Presbytery by its regional director and two others <u>ordained missionaries</u>. International Ministries shall be represented on the General Presbytery by its director and two others <u>ordained missionaries</u>. [See Bylaws, Article II, Section 2, paragraph d, (2).]

Mario M. Duque moved to amend the resolution by inserting "missionary" before "departmental" in ARTICLE II. ELECTION OF OFFICERS AND PRESBYTERS, Section 2. Nominations and Elections, paragraph d. General Presbyters, subparagraph (3). The chair ruled the motion out of order because this change would create an inconsistency in other governance documents where a department director is not required to be a missionary and would conflict with other places in the Bylaws where even the Assemblies of God U.S. Missions Executive Director is not required to be a missionary.

# RESOLUTION 1—DISTRICT REPRESENTATIVATES ON GENERAL PRESBYTERY

General Council Minutes August 2–4, 2023 PAGE 13 OF 57

On behalf of the General Presbytery, Larry H. Griswold, a member of the Resolutions Committee, moved adoption of the motion that follows. The motion was adopted as presented.

- WHEREAS, The three general presbyters each district is permitted to send to the General Presbytery are required to meet specific qualifications that are intended to include both district officer involvement and local field ministry involvement; and
- WHEREAS, While the present requirement for field representation by a district's third general presbyter has been restricted to a lead pastor only, over time it has been observed that spiritual eldership and proven ministry can also reside in an ordained minister serving in other roles; and
- WHEREAS, The input and involvement of a variety of leaders is valuable, and having individuals serving in active local Assemblies of God ministries is extremely valuable; and
- WHEREAS, Each district in session may choose from among them a spiritually mature minister known to the district to carry the necessary biblical qualifications for spiritual eldership; and
- WHEREAS, We see value in whatever standards are adopted to be a consistent standard across all districts rather than varying from one district to the next; and
- WHEREAS, The proposed change does not preclude a lead pastor from being chosen but simply opens the options to candidates serving in other ministry roles as well; therefore, be it
- RESOLVED, That General Council Constitution ARTICLE IX. OFFICERS AND PRESBYTERIES OF THE GENERAL COUNCIL, Section 3. General Presbytery, paragraph a. Representation, qualifications, and responsibilities, page 17, which reads:

#### **Section 3. General Presbytery**

a. Representation, qualifications, and responsibilities. The General Presbytery shall be composed of individuals of maturity, experience, and ability whose lives and ministry are above reproach, who shall represent the Fellowship in all phases of its work in their respective fields. The General Presbytery shall be the official policy-making body of the Assemblies of God when the General Council is not in session. Each district shall have the privilege of representation on the General

Presbytery by three members—the district superintendent together with two others who shall be elected by their district council, one of whom shall be an ordained pastor of a church located in the district. They shall take office immediately.

The General Presbytery shall composed of Assemblies of God ordained ministers individuals of maturity, experience, and ability whose lives and ministry are above reproach, who shall represent the Fellowship in all phases of its work in their respective fields. They shall take office immediately.

(1) District representatives. In addition to the superintendent of each district, who shall serve on the General Presbytery by virtue of office, two others shall be elected by the district council in session, both of whom shall be ordained Assemblies of God ministers, and at least one of whom shall be a pastor of a church or a person involved in other ministry located in the district. They shall take office immediately upon election.

#### Be amended to read:

(1) District representatives. In addition to the superintendent of each district, who shall serve on the General Presbytery by virtue of office, two others shall be elected by the district

#### **RESOLUTION 3—RESTORATION REPORTS**

On behalf of the Resolutions Committee, William H. Rodriguez, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, It is the responsibility of the General Presbytery to establish policies, guidelines, and requirements for the restoration of ministers; and
- WHEREAS, During the 2021 General Presbytery meeting, newly revised restoration manuals and addendums were adopted for the purpose of using said materials in the restoration process for ministers; and
- WHEREAS, It is not desirable or necessary for the General Council Constitution and Bylaws document to stipulate a specific

timeline for the submission of required reports for ministers in a restoration program since the frequency varies and policies and requirements may change; therefore, be it

RESOLVED, General Council Bylaws ARTICLE X. DISCIPLINE, Section 8. Restoration, paragraph b. Procedures and requirements, subparagraph (1), h, page 68, which reads:

#### Section 8. Restoration

- b. Procedure and requirements.
  - (1) Restoration requirements.
  - (h) *Reports*. The minister must submit reports quarterly to the district superintendent.

#### **RESOLUTION 4—RECOGNITION OF DIVORCE/ANNULMENT**

On behalf of the Resolutions Committee, Paul R. Alexander, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, The various categories of divorce recognition have been approved at various times in history, thus, making the reading of the General Council Bylaws fragmented concerning the five categories; and
- WHEREAS, It would be beneficial to bring clarity and consolidation when referencing the five various categories of divorce recognition; and
- WHEREAS, The Executive Presbytery requested the general secretary to review and consider recommending a revision of the General Council Bylaws provision, addressing ecclesiastical annulment (Article VII, Section 2, paragraph k); and
- WHEREAS, It was determined that a clearer definition of ecclesiastical annulment would be helpful; therefore, be it
- RESOLVED, That General Council Bylaws ARTICLE VII. MINISTRY, Section 2. Basic Qualifications, paragraphs j. Marriage

status and k. Ecclesiastical annulments and marriage dissolutions, pages 46–47, which reads:

**j. Marriage status.** We disapprove of any married persons holding ministerial credentials with the Assemblies of God if either marriage partner has a former spouse living, unless the divorce occurred prior to his or her conversion or for the scriptural causes of a former spouse's marital unfaithfulness (Matthew 19:9), or the abandonment of the believer by the unbeliever (1 Corinthians 7:10–15), or in the case of domestic violence by a spouse to a spouse or child (Psalms 11:5; 146:5–9; Proverbs 6:16; Isaiah 1:16–17; Ephesians 4:1–3, 31–32; Ephesians 5), except as hereinafter provided.

# k. Ecclesiastical annulments and marriage dissolutions.

The Executive Presbytery shall have the authority to determine whether an applicant qualifies ecclesiastical annulment. In such cases there must be clear and satisfactory evidence of deception, fraud, or other conditions which have a profound impact preventing the creation of a valid marriage union, unknown at the time of marriage by the applicant. The Executive Presbytery shall have the authority to determine whether an applicant qualifies regarding a former marriage when the termination of that marriage is consistent with the scriptural position of the Fellowship relating to the granting or holding of ministerial credentials; or if a former marriage ended prior to conversion. In those cases involving preconversion divorce they shall be decided on an individual basis just as those that deal with ecclesiastical annulments. Appeals from the decisions of the Executive Presbytery may be made to the General Presbytery.

#### Be amended to read:

- **j. Marriage status.** We disapprove of any married persons holding ministerial credentials with the Assemblies of God if either marriage partner has a former spouse living, unless the divorce is recognized under one of the following biblical categories:
- (1) Recognition of preconversion divorce occurred prior to his or her conversion (2 Corinthians 5:17); or for the scriptural causes of a former spouse's marital unfaithfulness, or the
- (2) Recognition of abandonment of the believer by the unbeliever (1 Corinthians 7:10–15);

- (3) Recognition of spousal infidelity (Matthew 19:9); or in the case of
- (4) Recognition of domestic violence by a spouse to a spouse or child (Psalms 11:5; 146:5–9; Proverbs 6:16; Isaiah 1:16–17; Ephesians 4:1–3, 31–32; Ephesians 5 Matthew 18:6, Ephesians 5:28-33, Colossians 3:19); except as hereinafter provided.
- Recognition of ecclesiastical annulment—a pronouncement declaring a marriage invalid as hereinafter provided (Proverbs 12:22: Matthew 19:6: 1 Corinthians 7:5): k. Ecclesiastical annulments and marriage dissolutions. The Executive Presbytery shall have the authority to determine whether an applicant qualifies for an ecclesiastical annulment. In such cases there must be clear and satisfactory evidence of deception, or fraud, or other conditions which have a profound impact preventing the creation of a valid marriage union, unknown to the applicant at the time of marriage. by the applicant. Additionally, the lack of consummation or other conditions which have a profound impact preventing the creation of a valid marriage union can constitute an ecclesiastical annulment. The Executive Presbytery shall have the authority to determine whether an applicant qualifies regarding a former marriage when the termination of that marriage is consistent with the scriptural position of the Fellowship relating to the granting or holding of ministerial credentials; or if a former marriage ended prior to conversion.

Each In those cases requiring a recognition of involving preconversion divorce or ecclesiastical annulment they shall be decided by the Executive Presbytery on an individual basis just as those that deal with ecclesiastical annulments. as to whether the termination of that marriage is consistent with the scriptural position of the Fellowship relating to the granting or holding of ministerial credentials. Appeals of from the decisions of the Executive Presbytery may be made to the General Presbytery.

# RESOLUTION 17—ALIGNING DIVORCE PROVISIONS THROUGHOUT THE BYLAWS

On behalf of the Executive Presbytery and the General Presbytery, Paul R. Alexander, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted.

- WHEREAS, For ministerial credentialing purposes, The General Council will recognize a divorce when the former spouse is still living in one of the following circumstances as supported by Scripture: (1) the divorce occurred prior to the applicant's conversion; (2) the former spouse's infidelity; (3) abandonment of the believer by the unbeliever; (4) domestic violence by a spouse to the applicant or child; or (5) ecclesiastical annulment; and
- WHEREAS, Portions of The General Council Bylaws have not been updated to align with the above named positions; and
- WHEREAS, This incongruity seems to hold parishioners and church board members to a different standard than credentialed ministers with regard to remarriage; and
- WHEREAS, The provision for recognition of a divorce for a credential applicant or spouse is supported by Scripture and should also apply to congregants and lay people; therefore, be it
- RESOLVED, That General Council Bylaws ARTICLE IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 5. Divorce and Remarriage, paragraph b. Remarriage, page 59, which reads:
  - **b.** Remarriage. Low standards on marriage and divorce are very hurtful to individuals, to the family, and to the cause of Christ. Therefore, we discourage divorce by all lawful means and teaching. We positively disapprove of Christians getting divorces for any cause except fornication and adultery (Matthew 19:9). Where these exceptional circumstances exist or when a Christian has been divorced by an unbeliever, we recommend that the question of remarriage be resolved by the believer in the light of God's Word (1 Corinthians 7:15, 27–28).

Be amended to read:

**b.** Remarriage. Low standards on marriage and divorce are very hurtful to individuals, to the family, and to the

cause of Christ. Therefore, we discourage divorce by all lawful means and teaching. We positively disapprove of Christians getting divorces for any cause except fornication and adultery (Matthew 19:9), or the abandonment of the believer by the unbeliever (1 Corinthians 7:10–15), or in the case of domestic violence by a spouse to a spouse or child (Matthew 18:6; Ephesians 5:28-33; Colossians 3:19). Where these exceptional circumstances exist or when a Christian has been divorced by an unbeliever, we recommend that the question of remarriage be resolved by the believer in the light of God's Word (Matthew 19:3-12; 1 Corinthians 7:10-28 15, 27-28).

#### And, be it therefore further

- RESOLVED, That The General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 5 Divorce and Remarriage, paragraph e. Ministerial credentials, page 60 which reads:
  - e. Ministerial credentials. We disapprove of any married minister of the Assemblies of God holding credentials if either minister or spouse has a former spouse living unless the divorce occurred prior to conversion (2 Corinthians 5:17) or for the scriptural causes of a former spouse's marital unfaithfulness (Matthew 19:9) or the abandonment of the believer by the unbeliever (1 Corinthians 7:10–15) or in the case of domestic violence by a spouse to a spouse or child (Psalms 11:5; 146:5–9; Proverbs 6:16; Isaiah 1:16–17; Ephesians 4:1–3, 31–32; Ephesians 5). (See also Bylaws, Article VII, Section 2, paragraphs j and k.)

#### Be amended to read:

e. Ministerial credentials. We disapprove of any married minister of the Assemblies of God holding credentials if either minister or spouse has a former spouse living unless the divorce occurred prior to conversion (2 Corinthians 5:17), or for the scriptural causes of a former spouse's marital unfaithfulness (Matthew 19:9) or the abandonment of the believer by the unbeliever, (1 Corinthians 7:10–15) or in the case of domestic violence by a spouse to a spouse or child (Psalms 11:5; 146:5–9; Proverbs 6:16; Isaiah 1:16–17; Ephesians 4:1–3, 31–32; Ephesians 5 Matthew 18:6; Ephesians 5:28-33; Colossians 3:19), or an ecclesiastical annulment. (See also Bylaws, Article VII, Section 2, paragraphs j and k.)

#### RESOLUTION 18—SUBSEQUENT DISMISSAL CLARIFIED

On behalf of the Executive Presbytery and the General Presbytery, Jason L. McClaflin, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted.

- WHEREAS, The provision for a subsequent dismissal is provided for and sought when a minister's previous credential status was either resigned, lapsed, or not renewed; and
- WHEREAS, The wording in The General Council Bylaws does not specifically name the "not renewed" status to be included although it is implied; and
- WHEREAS, Legal counsel for The General Council has advised that it would be prudent to revise the wording to match the intention and practice of the provision to specifically include the "not renewed" option; therefore be it
- RESOLVED, That the General Council Bylaws ARTICLE X. DISCIPLINE, Section 9. Referral for Action to the General Council Credentials Committee, paragraph a. District recommendation, subparagraph (3), page 69 which reads:
  - (3) Subsequent dismissal. Should evidence come to light following a minister's resignation, or the lapse of his or her credentials, of conduct occurring prior to his or her resignation or lapse of credentials that would constitute grounds for disciplinary action under Article X, Section 3, of these Bylaws, the district at its discretion may request the General Council Credentials Committee to change that minister's status from lapsed or resigned to dismissed. The district shall inform the minister involved of its action and, where applicable, the superintendent of the minister's district of affiliation. All rights of appeal will apply.

#### Be amended to read:

(3) Subsequent dismissal. Should evidence come to light, following a minister's resignation, or the lapse of his or her termination of credentials, (whether by lapse, resignation, or not renewed), of conduct occurring prior to said change of credential status his or her resignation or lapse of credentials that would constitute grounds for disciplinary action under Article X, Section 3, of these Bylaws, the district at its discretion may request the General Council Credentials Committee to change that minister's credential status from

lapsed or resigned to dismissed. The district shall inform the former minister involved of its action and, where applicable, the superintendent of the minister's district of affiliation. All rights of appeal will apply.

### **EXECUTIVE DIRECTOR OF WORLD MISSIONS REPORT**

Executive Director of World Missions Gregory M. Mundis presented a report. By general consent, a motion was adopted to accept the report with deep appreciation.

#### **RESOLUTION 5—PUBLICATION OF DISMISSAL**

On behalf of the Resolutions Committee, Jason L. McClaflin, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, The right of appeal, complete with details is mentioned in its appropriate place at General Council Bylaws Article X. Discipline, Section 10. Right of Appeal; and
- WHEREAS, When it is mentioned a second time under Publication of Dismissal in Section 11, yet without all the details, it can be misleading; and
- WHEREAS, The intention of the statement in Section 11 is to clarify that the dismissal should not be publicized until the thirty-day window is completed after notification, giving the credential holder the right to appeal without public announcement; and
- WHEREAS, By stating "An additional thirty days" suggests confusion that there is possibly a time frame beyond the first thirty days of the time limit within which an appeal may be communicated, which is not the case; therefore, be it
- RESOLVED, That General Council Bylaws, ARTICLE X. DISCIPLINE, Section 11. Publication of Dismissal, page 70, which reads:

No publication of a dismissed minister's name, in print or electronically, shall be made until the district has been advised by the office of the general secretary that such has been authorized by the General Council Credentials Committee. An additional thirty (30) days from the date of the notification shall be given the dismissed minister to exercise the right of appeal.

#### Be amended to read:

No publication of a dismissed minister's name, in print or electronically, shall be made until (1) the district has been advised by the office of the general secretary that such has been authorized by the General Council Credentials Committee and (2) the thirty (30) day right of appeal has passed. An additional thirty (30) days from the date of the notification shallbe given the dismissed minister to exercise the right of appeal.

#### **RESOLUTION 6—RIGHT OF APPEAL**

On behalf of the Resolutions Committee, Janelle Marocco, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, Some confusion has arisen concerning the General Council Bylaws Article X requirements for disciplined ministers in the filing of formal ministerial appeals to the General Council Credentials Committee and the General Presbytery; and
- WHEREAS, General Council Bylaws Article X. Discipline, Section 10, paragraph a, page 69, reads that an appeal to the General Council Credentials Committee "should include any new or exculpatory information not previously considered"; and
- WHEREAS, General Council Bylaws Article X. Discipline, Section 10, paragraph c, page 70, reads that an appeal to the General Presbytery "must include new exculpatory information"; and
- WHEREAS, The General Presbytery has reviewed said policy and determined the present language in the General Council Bylaws Article X should be revised to bring into agreement the language regarding "new exculpatory information" for both the appeal to the General Council Credentials Committee and the appeal to the General Council; therefore, be it
- RESOLVED, That General Council Bylaws ARTICLE X. DISCIPLINE, Section 10. Right of Appeal, paragraph a, page 69, which reads:
  - a. Filing of appeal to the General Council Credentials Committee. The right of appeal applies to all actions of discipline and termination of credentials other than lapsing or resigning on the initiative of the minister. An accused minister shall have thirty (30) days from the date notification of the General Council Credentials Committee's decision was mailed to appeal to the General Council Credentials Committee. The minister shall be apprised officially of this right at the time notification is given to the minister of the decision of the General Council Credentials Committee. The appeal is to be sent to the office of the general superintendent, and should include any new or exculpatory information not previously considered, with copies sent to the superintendent of the minister's district of affiliation and any other districts involved.

Be amended to read:

a. Filing of appeal to the General Council Credentials Committee. The right of appeal applies to all actions of discipline and termination of credentials other than lapsing or resigning on the initiative of the minister. An accused minister shall have thirty (30) days from the date notification of the General Council Credentials Committee's decision was mailed to appeal to the General Council Credentials Committee. The minister shall be apprised officially of this right at the time notification is given to the minister of the decision of the General Council Credentials Committee. The appeal is to be sent to the office of the general superintendent, and must should include any new or exculpatory information not previously considered, with copies sent to the superintendent of the minister's district of affiliation and any other districts involved.

# RESOLUTION 11—COMMISSION ON DOCTRINES AND PRACTICES ORDAINED MEMBERS

On behalf of the Executive Presbytery and the General Presbytery, Nathan L. Sheridan, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, Members appointed to the Commission on Doctrines and Practices have traditionally been ordained with the Assemblies of God even though the General Council Constitution and Bylaws does not state that as a requirement; and
- WHEREAS, It is beneficial for a variety of reasons to clarify and require that members appointed to the Commission on Doctrines and Practices be ordained with the Assemblies of God; and
- WHEREAS, additional auditors have been appointed from time to time to assist the Commission on Doctrines and Practices as needed and this continues to be an option; therefore be it
- RESOLVED, That General Council Bylaws ARTICLE IX. DOCTRINES AND PRACTICES DISAPPROVED, A. Commission on Doctrines and Practices, paragraph b. Appointments and terms of office, page 57, which reads:
  - **b. Appointments and terms of office**. The commission shall be appointed by the Executive Presbytery and shall consist of ten (10) members representing, insofar as possible, the area

divisions of the Assemblies of God. Members shall be recognized authorities in biblical knowledge. Their terms of office shall be for four (4) years.

#### Be amended to read:

b. Appointments and terms of office. The commission shall be appointed by the Executive Presbytery and shall consist of ten (10) members representing, insofar as possible, the area divisions of the Assemblies of God. Members shall be ordained ministers with the Assemblies of God and recognized authorities in biblical knowledge.—Their terms of office shall be for four (4) years.

#### **RESOLUTION 12—GENERAL PRESBYTERY DISTRICT AUDITORS**

On behalf of the Executive Presbytery and the General Presbytery, William H. Rodriguez, a Member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, The requirement that a district's auditor to the General Presbytery be a "full-time executive presbyter or officer" is difficult to follow; and
- WHEREAS, This requirement is unable to be verified by the national office when the request is submitted; and
- WHEREAS, This requirement is unfair to districts whose officers are bivocational; and
- WHEREAS, This requirement seems irrelevant to today's culture in which most leaders are filling multiple roles, some in the district office and some in other district ministries; and
- WHEREAS, Some might narrowly define "full-time" as a 40-hour work week, while many in ministry serve multiple positions or a combination and variety of roles; and
- WHEREAS, It is uncommon for any district to have a full-time district executive presbyter; therefore, be it
- RESOLVED, That General Council Bylaws ARTICLE II. ELECTIONS OF OFFICERS AND PRESBYTERS, Section 2. Nominations and Elections, paragraph d. General presbyters, subparagraph (8), *Auditors*, (c) page 28, which reads:
  - (c) A district may select no more than one auditor for all duly called sessions of the General Presbytery. Any auditor selected

by a district shall be one of its full-time executive presbyters or officers. Expenses for the district auditors shall not be the responsibility of the General Council.

#### Be amended to read:

(c) A district may select no more than one auditor for all duly called sessions of the General Presbytery. Any auditor selected by a district shall be one of its full-time executive presbyters or officers. Expenses for the district auditors shall not be the responsibility of the General Council.

On behalf of the Ohio Ministry Network, Central Pacific Ministry Network Board and District Presbytery, Florida Multicultural Executive Presbytery, New Mexico Ministry Network Presbytery, Pennsylvania-Delaware Ministry Network, South Dakota Presbytery, Southern New England Ministry Network Executive Presbytery, and Wisconsin-Northern Michigan Ministry Network Presbytery, Janelle Marocco, a Member of the Resolutions Committee, moved the adoption of the resolution that follows.

- WHEREAS, Ministry is becoming more complex in light of a changing landscape culturally, legally, ethically, and financially; and
- WHEREAS, Understanding of the most current information and best practices in various areas of ministry more readily equips ministers to competently navigate rising challenges; and
- WHEREAS, When ministers are uninformed, they may put the ministry they lead, their district, the General Council, and themselves at greater risk for harm legally, relationally, and in their public witness; and
- WHEREAS, Ongoing training related to theology, biblical studies, and ministry practice including ethics, risk management, and financial stewardship are beneficial for every minister in both their personal growth life and in their service as a minister; therefore be it
- RESOLVED, That General Council Bylaws Article VII. MINISTRY, Section 10. Credential Renewals and Reinstatements, pages 53-54, be amended by inserting a new subparagraph g, page 54, to read:
  - g. A minimum cumulative total of one (1) hour of online training must be completed annually in the renewal process. Completion of the continuing education requirement shall be a prerequisite for renewal of credentials of all active ministers; and, be it further
- RESOLVED, That these changes would not go into effect until September 1, 2024, to allow for the general secretary's office to properly prepare for any adjustment required in the renewal process.

John Wootten moved to amend the resolution by substituting the resolution that follows:

Completion of the continuing education requirement, as approved by the Executive Presbytery, shall be a prerequisite for renewal of credentials of all active ministers, with exception given for extenuating circumstances such as, but not limited to, issues of internet access and connectivity to be approved by the minister's district;

And, be it further

RESOLVED, That these changes would not go into effect until September 1, 2024, to allow for the general secretary's office to properly prepare for any adjustment required in the renewal process.

Don E. Miller moved to refer the Resolution, with the pending substitute amendment, to a committee to be appointed by the Executive Presbytery to consider this resolution in conjunction with the substitute resolution and report back to the General Presbytery in 2024. The motion was adopted.

#### RESOLUTION 19—COMMISSION ON CHAPLAINS

On behalf of the Executive Presbytery and the General Presbytery, Janelle Marocco moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, Prior to 1973, Chaplaincy was in two separate departments in the National Office; and
- WHEREAS, In 1973, the two Chaplaincy ministries were joined together into one department under U.S. Missions, but continued to function under two different cost centers for recordkeeping; and
- WHEREAS, The Commission on Chaplains voted to unify the department in November 2019; and
- WHEREAS, The General Council Bylaws needs to be refreshed in order to align with current practice; therefore be it
- RESOLVED, That the General Council Bylaws Article XIV. ASSEMBLIES OF GOD U.S. MISSIONS, Section 2. Organization and Governance, paragraph g, pages 77–78, which reads:

#### g. Commission on Chaplains

- (1) Composition. The Commission on Chaplains shall consist of the executive director of Assemblies of God U.S. Missions, representatives of the Military/Veterans Affairs and Institutional/Occupational Chaplaincies, one of whom shall be the department director of Chaplaincy Ministries, two executive presbyters, two Military/Veterans Affairs chaplains, two Institutional/Occupational chaplains, two members at large, legal counsel, and others at the discretion of the Executive Leadership Team. The commission shall serve as the endorsing agency for The General Council of the Assemblies of God. Members of the commission and its chairperson shall be appointed by the Executive Presbytery.
- (2) Authority and amenability. The government and work of Chaplaincy Ministries shall be vested in and committed to the Commission on Chaplains. The commission shall operate within guidelines adopted by the Executive Presbytery. It shall have the responsibility to evaluate policies, to offer guidance and counsel in the area of its supervision, to establish criteria for the appointment of workers in the Military/Veterans Affairs, Institutional/Occupational Chaplaincies, and to sit as a Board of Appeal in all matters

relating to its area of supervision. It shall be amenable to and under the general supervision of the Executive Presbytery and the General Presbytery.

Be amended to read:

#### g. Commission on Chaplains

- Composition. The Commission on Chaplains shall consist of the executive director of Assemblies of God U.S. Missions, the national representatives of the Military/Veterans Affairs and Institutional/ Occupational Chaplaincies, Chaplaincy Department, one of whom shall be the department senior director of Chaplaincy Ministries, two executive presbyters, two Military/ Veterans Affairs chaplains, two Institutional/Occupational chaplains, four chaplains from the various areas of Chaplaincy Ministries, two members at large, legal counsel, and others at the discretion of the Executive Leadership Team, to include representatives from the Military, Health Care and Correctional ministries. The commission shall serve as the endorsing agency for The General Council of the Assemblies of God. Members of the commission and its chairperson shall be appointed by the Executive Presbytery.
- (2) Authority and amenability. The government and work of Chaplaincy Ministries shall be vested in and committed to the Commission on Chaplains. The commission shall operate within guidelines adopted by the Executive Presbytery. It shall have the responsibility to evaluate policies, to offer guidance and counsel in the area of its supervision, to establish criteria for the appointment of workers in the Military/Veterans Affairs, Institutional/Occupational Chaplaincies, Chaplaincy Ministries, and to sit as a Board of Appeal in all matters relating to its area of supervision. It shall be amenable to and under the general supervision of the Executive Presbytery and the General Presbytery.

Nonresident executive presbyters, subparagraph (2)(c) Additional representation, page 27, provides for three additional members of the Executive Presbytery selected by the General Council from a list of nominees provided by the General Presbytery; and
- WHEREAS, The General Presbytery must select and submit four nominees for each position to the General Council and the list from which those nominees are selected is provided by more than sixty districts who may each submit their own nominee; and
- WHEREAS, Numerous districts have been challenged with the requirement to submit a nominee selected at their district council in time for General Council because their district councils are held in the summer; and
- WHEREAS, It is reasonable that names and photos of nominees be received by the general secretary's office in a timely fashion; and
- WHEREAS, The General Presbytery only convenes once each year, typically during the week of General Council, and are thus disadvantaged by needing to quickly select names from large lists of nominees based on relatively little familiarity with each of the candidates; and
- WHEREAS, The Executive Presbytery meets multiple times per year and has the time for more extensive review and consideration of nominees; and
- WHEREAS, The General Council delegates would be well-served to have a list of nominees benefitting from the wisdom and perspective of the larger General Presbytery preceded by an initial review conducted by the Executive Presbytery; therefore, be it
- RESOLVED, That General Council Bylaws ARTICLE II. ELECTION OF OFFICERS AND PRESBYTERS, Section 2. Nominations and Elections, paragraph c. Nonresident executive presbyters, subparagraph (2)(c) Additional representation, page 27, which reads:

(c) Additional representation. The nomination process for three additional nonresident executive presbyters shall be made as follows: Each district council, at its annual meeting prior to the General Council session, may nominate three individuals from its district to the Executive Presbytery, one who is an ordained minister under forty (40) years of age at the time of election, one ordained female minister (no age requirement), and one ordained African-American minister (no age requirement). The members of the Executive Board of the National Black Fellowship shall also be considered nominees for the ordained African-American minister. From the nominees the General Presbytery shall select and submit to the General Council four names of ordained ministers under forty (40) years of age at the time of election, four names of ordained female ministers (no age requirement). and four names of ordained African-American ministers (no age requirement).

(c) Additional representation. The nomination process Nominations for three additional nonresident executive presbyters shall be made as follows: As determined bγ its district council, each district council shall assign a designated body (such as, but not limited to, their district presbytery or their district council) at its annual meeting prior to the General Council session, may to nominate three individuals from its district to the Executive Presbytery, one who is an ordained minister under forty (40) years of age at the time of election, one ordained female minister (no age requirement), and one ordained African-American minister (no age requirement). The members of the Executive Board of the National Black Fellowship shall also be considered nominees for the ordained African-American minister. From the nominees, the Executive Presbytery shall select and submit to the General Presbytery a minimum of eight nominees for each office. On behalf of the Executive Presbytery and the General Presbytery, Larry H. Griswold, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted.

- WHEREAS, The General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph a, page 57, was created in 1925 due to a teaching of universalism based on Acts 3:21 and it is now no longer an issue; and
- WHEREAS, The title "The restitution of all things" was based on this teaching from Acts 3:21; and
- WHEREAS, The second sentence, "We are opposed to all forms of universalism (Matthew 25:46; Revelation 20:10)" turned the paragraph into a statement prohibiting universalism in general; and
- WHEREAS, The title naming the eschatological error can be confusing; and
- WHEREAS, Renaming the paragraph "Universalism" clearly states what is in error; therefore be it
- RESOLVED, That the General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph a, page 57, which reads:
  - **a.** The restitution of all things. The Assemblies of God understands the teaching of Acts 3:21 to limit the restoration to that of which the prophets have spoken, thus denying the universal redemption theory. We are opposed to all forms of universalism (Matthew 25:46; Revelation 20:10).

**a. Universalism.** The restitution of all things. The Assemblies of God understands the teaching of Acts 3:21 to limit the restoration to that of which the prophets have spoken, thus denying the universal redemption theory. ### RESOLUTION 14—ESCHATOLOGICAL ERROR—DENIAL OF IMMINENT RETURN OF JESUS

On behalf of the Executive Presbytery and the General Presbytery, Larry H. Griswold, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted.

- WHEREAS, The General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph c., page 58, was written in light of only one eschatological error, namely post-tribulation rapture, which denies the imminent return of Christ; and
- WHEREAS, The primary reason for paragraph c was to preserve the teaching of Christ's imminent return to gather the resurrected Church; and
- WHEREAS, There are other teachings which also deny Christ's imminent return; and
- WHEREAS, Naming as an error any teaching, whether or not it revolves around the Tribulation, which denies Christ's imminent return will strengthen the reason for paragraph c; therefore be it
- RESOLVED, That the General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph c., page 58, which reads:
  - c. Post-Tribulation Rapture. The General Council of the Assemblies of God has declared itself in the Statement of Fundamental Truths that it holds to the belief in the imminent coming of the Lord as the blessed hope of the Church; and since the teaching that the Church must go through the Tribulation tends to bring confusion and division among the saints, it is recommended that all our ministers teach the imminent coming of Christ, warning all to be prepared for that coming, which may occur at any time, and not lull their minds into complacency by any teaching that would cause them to feel that specific Tribulation events must occur before the rapture of the saints.

b. <u>Denial of the Imminent Return of Jesus</u>. <u>Post-Tribulation Rapture</u>. The General Council of the Assemblies of God has declared itself in the Statement of Fundamental Truths that it holds to the belief in the

- WHEREAS, The General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph d, page 58, was written in response to only one eschatological error, namely amillennialism, which denies the reign of Christ on the earth after His bodily return; and
- WHEREAS, The primary reason for paragraph d was to preserve the premillennial teaching of Christ's bodily return and subsequent reign; and
- WHEREAS, There are other teachings which also deny the bodily return and subsequent reign of Christ; and
- WHEREAS, Naming as an error any teaching which denies Christ's reign on earth following His bodily return will strengthen the reason for paragraph d; therefore be it
- RESOLVED, That the General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph d., page 58, which reads:
  - **d. Amillennialism.** The General Council of the Assemblies of God disapproves of the amillennial teaching and its attendant erroneous philosophy which denies the fact of a literal one thousand-year reign of Christ on the earth, and substitutes for it the theory that this Christian or Church dispensation is the spiritual Millennium of which, its proponents say, the Bible writers prophesied.

Be amended to read:

**d.** Amillennialism and the Denial of the bodily reign of Christ. The General Council of the Assemblies of God disapproves of the amillennial amillennialism and any teaching and its attendant erroneous philosophy which denies the fact of a literal one thousand-year reign of Christ on the earth, following His bodily return, and substitutes for it the theory that this present age is the spiritual millennium. Christian or Church dispensation is the spiritual Millennium of which, its proponents say, the Bible writers prophesied.

### RESOLUTION 16—ESCHATOLOGICAL ERROR—INTENT TO LEAD OTHERS ASTRAY

On behalf of the Executive Presbytery and the General Presbytery, Larry H. Griswold, a member of the Resolutions Committee, moved the adoption of the resolution that follows. The motion was adopted as presented.

- WHEREAS, The General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph e, page 58, recommends that ministers refrain from preaching or teaching any of the foregoing eschatological errors at the risk of their standing in the Fellowship; and
- WHEREAS, Explaining the errors may be necessary in explaining or defending the truths which those errors deny; and
- WHEREAS, Some may take "preaching or teaching" to mean any in-depth discussion of said eschatological errors regardless of intent; and
- WHEREAS, Teachers and preachers within the Fellowship should be encouraged to freely discuss eschatological views in passing on the faith; and
- WHEREAS, The intent of paragraph e is to prohibit the teaching or preaching of those errors in order to lead others to believe them; therefore be it
- RESOLVED, That the General Council Bylaws Article IX. DOCTRINES AND PRACTICES DISAPPROVED, B. LIST OF DOCTRINES AND PRACTICES DISAPPROVED, Section 3. Eschatological Errors, paragraph e, page 58, which reads:
  - e. Credentials jeopardized if made an issue. We recommend that those ministers who embrace any of the

foregoing eschatological errors refrain from preaching or teaching them. e. Credentials jeopardized if made an issue. Intent to lead others astray. We recommend that those A credentialed ministers minister who embrace embraces any of the foregoing eschatological errors these teachings must refrain from preaching or teaching them intentionally leading other people to adopt the positions. Should they persist in emphasizing these doctrines to the point of making them an issue, their standing in the Fellowship will be seriously affected. - WHEREAS, Said provision required publications to use only King James Version or print both the other version and the King James Version beside each Scripture entry, which practice has continued to today; and
- WHEREAS, To change said guideline as it presently exists requires the action of the General Council in session because said requirement was built into said original resolution; and therefore be it
- RESOLVED, That the General Council of the Assemblies of God rescind Resolution 26 from the 1995 General Council.
